Fund update for the year ended 30 June 2024.

What is the purpose of this update?

This document tells you how the Cash Fund (**Fund**) has performed and what fees were charged. The document will help you to compare the Fund with other funds. As Trustee of the Employee Retirement Plan, Public Trust prepared this update in accordance with the Financial Markets Conduct Act 2013. This information is not audited and may be updated.

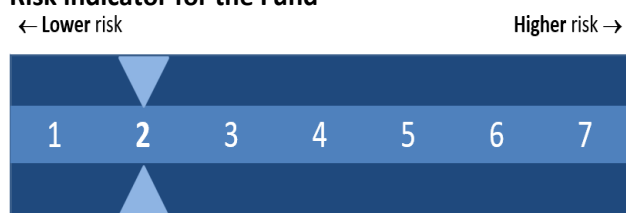
Description of this fund

The Fund has a target asset allocation of 100% to cash. The Fund may be suitable for investors who want to decrease their possibility of losing capital. Investors need to be comfortable with the possibility of small fluctuations in returns.

What are the risks of investing?

Risk indicator for the Fund



The risk indicator is rated from 1 (low) to 7 (high). The rating reflects how much the value of the Fund's assets goes up and down. A higher risk generally means higher potential returns over time, but more ups and downs along the way.

Note that even the lowest category does not mean a risk-free investment, and there are other risks that are not captured by this rating.

This risk indicator is not a guarantee of a fund's future performance. The risk indicator is based on the returns data for the five year period to 30 June 2024. While risk indicators are usually relatively stable, they do shift from time to time. The risk indicator will continue to be updated in future fund updates.

The risks associated with investing in the Fund include:

Investment portfolio and asset class risk: The Fund will be subject to the particular risks applying to the types of assets in which the Fund invests.

Market risk: Returns on the Fund’s investments will be affected by the performance of investment markets generally. Market performance is affected by supply and demand, economic, technological, political, tax and regulatory conditions as well as market sentiment.

Interest rate risk: The Fund’s market value includes fixed income securities which can change due to changes in interest rates. Relatively small changes in interest rates can significantly impact the market value of fixed income assets.

How has the fund performed?

The market index on which the market index annual return is based is the short-term government bank bill index (NZX/S&P Bank Bills 90-Day Index).



This shows the return after fund charges and tax for each of the last 10 years ending 30 June. The last bar shows the average annual return for the past 10 years, up to 30 June 2024. The Fund’s returns are shown after deductions for fund charges and tax.

Small differences in fees and charges can have a big impact on your investment over the long term.

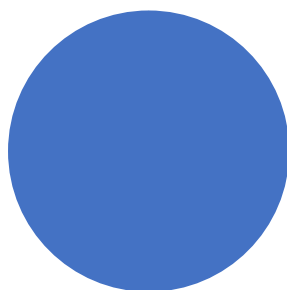
Example of how this applies to an investor

Mary had \$10,000 in the Fund at the start of the year and did not make any further contributions. At the end of the year, Mary received a return after fund charges were deducted of \$566 (that is 5.66% of her initial \$10,000). Mary paid \$24.84 in other charges. This gives Mary a total return after tax of \$380.16 for the year.
